Scott Filipek, President of the Arlington Heights School District 25 Board of Education, called the meeting to order on March 17, 2022 to accept a motion to adjourn into closed session at 6:19 p.m. The meeting was held at the Dunton Administration Building, 1200 S. Dunton Avenue, Arlington Heights, Illinois.

- NSSEO – Mr. Filipek reported on the past two meetings. Recently at NSSEO, a Thomas Middle School student was highlighted as the Shining Star as he was transitioning back from Timber Ridge to Thomas Middle School. Also, the Timber Ridge ribbon cutting ceremony was a great event. Mr. Olejniczak and Ms. Patel also attended.
- IASB – Ms. Patel reported that the IASB Dinner Meeting will be held on April 20 at Lincoln Middle School in Skokie with a presentation from Ralph Martire. She noted that she completed the four-part IASB Book study on Crucial Conversations.

- ED-RED – Mr. Olejniczak reported that the ED-RED dinner meeting will be held on April 25. He shared updates on several bills, and reminded the Board to complete their Statement of Economic Interests by May 2.
- A Board Governance Framework – Mr. Filipek read an excerpt from the Board Governance Framework regarding meetings of the Board.
- Other Board Communication – Mr. Filipek spoke about the Board Coffee that was held the previous weekend, and reminded the public that this is a time they can come to speak informally with Board members. Mr. Olejniczak congratulated Music for Youth on their recent concert. Mr. Filipek noted that he was in attendance and also congratulated the group. Mrs. Patel mentioned that the Arlington Heights Chamber of Commerce celebrated their 75<sup>th</sup> anniversary with a gala, and she thanked the local business community for their support of District 25.

Ms. Mallek reported on the proposed fees for technology, transportation, food service, student fees, additional fees, and the Children's Circle tuition. She noted that student fees are waived for students qualifying for the Free and Reduced Lunch Program.

##### Summer Construction Bid Awards

Mr. Schulz shared a summary of the three bids recommended for approval by the Board of Education. He explained that we utilize a construction manager depending on the scope of the work and the district's needs in getting materials, and the work completion timeline.

Cerniglia seconded the motion that the Board of Education award Bid Package #1, Base Bid while rejecting Alternates 1, 2, & 3 for General Trades to Monarch Construction in the amount of \$959,200 for 2022 Capital Improvements and immediately assign the contract with the Contractor to Nicholas & Associates, Inc., as construction manager.

And that the Board of Education award Bid Package #2, Base Bid while rejecting Alternates 1, 2, & 3 for HVAC to DeKalb Mechanical in the amount of \$890,000 for 2022 Capital Improvements and immediately assign the contract with the Contractor to Nicholas & Associates, Inc., as construction manager.

And that the Board of Education award Bid Package #3, Base Bid while rejecting Alternates 1, 2, & 3 for Electrical to Shoreline Electric in the amount of \$120,000 for 2022 Capital Improvements and immediately assign the contract with the Contractor to Nicholas & Associates, Inc., as construction manager.

Superintendent Report

Freedom of Information Act Report

Dr. Bein reported that the following FOIAs have been received and responded to.

- Katie Rausch requested information on data from a survey used as a data point to assess Ivy Hill; a response was provided on March 7, 2022.

#### Strategic Plan Update

Dr. Bein, Dr. FitzPatrick, Dr. Lasiewicki, Ms. Mallek, and Dr. Kaye updated the Board on the five goals for the Strategic Plan. Information provided by the Action Team work was shared. As the process moves into the “Do” phase of the “Plan/Do/Study/Act” process, they also shared some of the steps they will be working on and how some aspects will be measured.

Board members had questions and there was discussion on an interest in understanding more of the actual steps staff is taking; seeing more data points as we project growth or achievement of goals; and the college and career ready goal and the importance of utilizing broader measures to assess it as well as the importance of supporting the career pathways. A Board member noted that District 25 has submitted a proposal to share the Strategic Plan’s equity focus at the Joint Annual Conference, and encouraged the staff to connect with the District 214 Director of Diversity and collaborate with District 214 on community-focused work. Board members asked additional questions about the measures and action steps. A Board member expressed appreciation for the staff’s work and noted the trust and faith the Board has in the administrators doing the work.

#### Board Meeting Structure

Dr. Bein asked the Board to revisit some areas of how Board meetings are structured. The Board determined that meetings for 2022-2023 will be scheduled on Tuesdays from 7:00 pm - 11:00 p.m. The Board will set a goal of finishing meetings by 10:00 p.m, but will have a “hard stop” at 11:00 p.m. The Board discussed putting time frames on agenda items as an estimate of how much time an item is planning to take.

The Board discussed the current process of accepting electronic comments. This was put in place in response to the pandemic-related restrictions in attendance and/or remote meetings. The Board asked if comments can be collected, but not read at meetings, but still available for Board review and posting on the website. Dr. Bein will check with legal counsel.

Ms. Patel described a format for a Policy Committee and other Board members agreed in the importance of the Board working on policies with rigor and focus. Dr. Bein will work with the Board to organize a Policy Committee.

The May 23, 2022 Board meeting will be relocated to South Middle School due to the Retirement Reception being scheduled at that meeting.

### Academy Program Review

Dr. Bein shared data with the Board that was collected from District 25 families who had children invited to the Academy Program. Some information shared included that 80% of families decided to have their student participate in the Academy when invited. Families responded that the best part of the Academy program was the teacher (42.5%) and the biggest challenge from the Academy Program was the multi-grade level classrooms (37.5%). Parents responded that if a remote program was needed in the future, they prefer those students be able to interact remotely with their actual classroom (37.6%).

Dr. Bein shared that we have utilized different formats for remote learning over the past few years, and would revisit this data should we need to offer remote learning in the future.

### Full Day Kindergarten

The Board had a detailed discussion about the combination of capital projects and construction for full-day kindergarten. They reviewed the costs associated with each, and how the costs included the five-year capital projects; the addition of classrooms in six elementary schools; the 85% capacity plan; the decision to not disrupt other programs; and the interest in not needing to go back to the voters in the next five years.

**Motion:** G. Scapillato moved and A. Patel seconded the motion that the Board of Education direct the Superintendent to implement Full Day Kindergarten in District 25 by August 2024 by taking the following actions:

- Pursue voter approval to issue the needed School Building Bonds to cover related construction costs and 5-year Capital Projects costs; and,
  - Build additional classroom space at Dryden, Greenbrier, Olive-Mary Stitt, Patton, Westgate, and Windsor Elementary Schools so that Full-day Kindergarten can be provided at each student's home school; and,
  - Collaborate with staff and families to recommend to the Board of Education the program design, instructional resources, personnel, and transportation details.

Resolution providing for and requiring the submission of the proposition of issuing \$75,000,000 School Building Bonds to the voters of the District at the general primary election to be held on the 28<sup>th</sup> day of June, 2022.

The Board, again, reviewed the costs associated with this motion, and discussed their commitment to bringing the topic to the community for input through the ballot question.

### Community Input Received Electronically

First and Last Name	Public Comments from the March 17, 2022 AHSD25 Board Meeting
Anne McCarte	<p>I'm writing because I was surprised to see Question 5 in the Remote Academy survey suggest that this program might be offered again in the future, and I didn't feel the survey allowed me to express my feedback fully.</p> <p>My second grader participated in Remote Academy during a ten-day quarantine in 2021. She participated enthusiastically, and the Academy teacher was wonderful in engaging very young children on multi-hour zoom calls. The students drew pictures, shared their work with their classmates, and listened to read-alouds. They did some work with currency. My daughter had no complaints about this program.</p> <p>That said, the board should understand that the curriculum of this program bore absolutely no resemblance to the work my daughter missed in class over those days. This program was not a substitute for take-home assignments from her teacher nor for zooming-in to her existing classroom. Upon my daughter's return to class, we were provided with some worksheets that I assume represented some of the work she missed. I would have preferred to have access to those worksheets during the quarantine period.</p> <p>Within my family and friends, I also know of four other elementary-aged students who participated in the Academy program during 2021, some of them for weeks at a time as the virus slowly worked its way through the home and the child's close-contact quarantine period repeatedly reset. Their experiences seemed to jibe with mine. The children were engaged – they enjoyed the program. The program provided structure to the day, which was valuable both for parent and child. But the Remote Academy curriculum did not mirror the classroom instruction in any way. The students missed weeks of relevant Tier 1 instruction. Two of the students missed weeks of their assigned Tier 2 interventions. Upon their return to class, they were provided with a stack of worksheets to work through over the coming evenings and weekends to help the children catch up to their peers.</p> <p>Given these experiences, I don't feel Remote Academy is a justifiable use of the district's resources. If funding continues to be available for the program, it should instead be directed toward meaningful services for students who need them – perhaps extra tutoring for students who miss their assigned Tier 2 interventions. When students must quarantine due to a COVID diagnosis, the teacher should send home work like they would with any other illness. Could the Seesaw assignments that have already been developed over the last three years during periods of remote learning be leveraged for this purpose? Please reconsider "zoom school" being a preferred approach for educating sick or excluded elementary students. The goal should be ensuring students are prepared to re-engage with the standard curriculum upon their return to class. Remote Academy does not satisfy this goal.</p>
Peggy Glaubke	<p>I'm writing today in response to the survey sent to me regarding Remote Academy. I'm surprised the survey had no option for open feedback and consequently writing to you in hopes of major reform moving forward.</p> <p>The teachers were the best part of Remote Academy and rose to the challenge of educating three different grade levels over Zoom for an extended period. They were kind, engaging, and fun to work with. However, by no means was this an even exchange for the education that was occurring in the classroom. There was no differentiation. The kindergarteners and 2nd graders had the same literacy instruction. 5th grade math was the same as 3rd grade math. When I realized my children were not receiving grade-appropriate literacy and math instruction, I asked multiple classroom teachers to send home the work being missed (particularly for my first grader who was already flagged as being behind in reading). When I was told that the teachers were</p>

	<p>not allowed to send home any work, I was devastated. As a parent, I was frustrated that I couldn't help my children stay current with the work that was already copied and sitting in the classroom. As an educator and member of a teacher's union, I felt mortified for the D25 teachers who were forced to tell me they couldn't help my children – their students – learn while stuck at home.</p> <p>I understand firsthand how the evolution of this pandemic impacted the workload of a teacher. I also know that trying to catch up students who missed two to three weeks is extremely challenging. If you have parents who are willing and able to help their children learn at home, why are you robbing them of that opportunity? The education and wellbeing of students should always be the center of every decision made, and this policy is quite frankly insulting to all the families this district serves.</p> <p>I feel like my children were punished for my being honest with the school about their health. If I hadn't openly told the school my children were quarantining, they could have had work sent home. The current policies of this district are forcing parents now to consider withholding information about their children's health in exchange for grade-appropriate material being sent home. Please reconsider your plan with Remote Academy moving forward to allow quarantined students the same opportunities that are afforded to the rest of the students in the classroom.</p>
Deborah Shiffman	<p>Dear Board,</p> <p>Please provide an explanation to address many questions many parents have regarding our board's local control. Please clarify what powers you hold as a school board in regards to preventing the enforcement of medical devices and medical treatments in the future. I'd like to hear from you, how are you going to ensure that transparency and accountability are #1 in our district? Thank you</p>
Tracy Falconer	<p>Did you ever wonder why no one ever tests positive for an old variant after a new one comes along?</p> <p>How do old covid tests manage to pick up a new variant that didn't exist when the test was made?</p> <p>Why do people get boosters for something that didn't work twice already?</p> <p>When was the last time you heard of a child dying from a heart attack, before the covid vaccines?</p> <p>It's hard to believe how millions of people lived through the past two years and concluded the government should have more power over their lives. What started as a battle against the pandemic to protect the people became a battle against the people to protect the pandemic. The question of who has given our board the authority over our children remains unanswered. No matter what your "authorities" told you to do, you took an oath and it was up to you to put pressure on your "authorities" to stop pressuring you and the community. What are the conclusions you have drawn to ensure nothing like this happens again? The more you avoid this conversation, the worse it looks.</p>

WHEREAS, the Board of Education (the "*School Board*") of School District Number 25, Cook County, Illinois (the "*District*"), has considered the existing school facilities and the improvements and extensions necessary to be made thereto in order that the same will adequately serve the educational needs of the District; and

WHEREAS, the School Board does hereby find and determine that it is necessary and in the best interests of the District that the School Board be authorized to improve the sites of, build and equip additions to and alter, repair and equip existing buildings, including, without limitation, building classrooms for full-day kindergarten and replacing windows, flooring, roofing, plumbing, electrical equipment and HVAC systems (the "*Project*"), at an estimated cost of \$75,000,000; and

WHEREAS, the School Board does hereby find and determine that the Project is needed to provide a quality educational program; and

WHEREAS, there are insufficient funds on hand and available to pay the costs of the Project; and

WHEREAS, before the School Board can provide the Project and borrow money and issue bonds for such purpose, a proposition therefor (the "*Proposition*") must be submitted to the voters of the District and be approved by a majority of the voters of the District voting on the Proposition at an election to be held in and for the District; and

WHEREAS, it is deemed advisable, necessary and in the best interests of the District that the Proposition be submitted to the voters of the District at an election to be held and conducted in accordance with the general election law:

NOW, THEREFORE, Be It and It Is Hereby Resolved by the Board of Education of School District Number 25, Cook County, Illinois, as follows:

*Section 1. Incorporation of Preambles.* The School Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

*Section 2. Need for Project.* It is necessary and in the best interests of the District that the School Board be authorized to provide the Project, and that it is necessary and in the best interests of the District that money be borrowed and in evidence thereof bonds of the District be issued therefor to the amount of \$75,000,000.

*Section 3. Submission to Voters.* The Proposition shall be submitted to the voters of the District in accordance with the general election law at the general primary election to be held on Tuesday, the 28th day of June, 2022, between the hours of 6:00 o'clock A.M. and 7:00 o'clock P.M. on said day (the "*Election*").

*Section 4. Voting Precincts and Polling Places.* The Election shall be held in the voting precincts and at the polling places established by the County Board (the "*County Board*") of The County of Cook, Illinois (the "*County*"), for voters of the District at the Election.

*Section 5. Election Notice.* The County Clerk of the County (the "*County Clerk*") shall give notice of the Election, including the Spanish, Chinese and Asian Indian translations thereof as deemed by the County Clerk to be required by law (the "*Notice*"), in accordance with the general election law by (i) publishing the Notice once not more than 60 nor less than 10 days prior to the date of the Election in a local, community newspaper having general circulation in the District, and (ii) posting a copy of the Notice at least 10 days before the date of the Election at the principal office of the County Clerk.

*Section 6. Local Notice.* The Secretary of the School Board shall post a copy of the Notice at the principal office of the District.

*Section 7. Newspaper of General Circulation.* It is hereby found and determined that the *Daily Herald* is a local, community newspaper having general circulation in the District as required by Section 12-5 of the Election Code of the State of Illinois, as amended (the "*Election Code*").

*Section 8. Form of Notice.* The Notice shall appear over the name or title of the County Clerk and shall be substantially in the following form:

NOTICE IS HEREBY GIVEN that at the general primary election to be held on Tuesday, the 28th day of June, 2022, the following proposition will be submitted to the voters of Arlington Heights School District Number 25, Cook County, Illinois:




