4:10 - There was a suggestion to include "zero based budgeting".

5:190 - 1.b, there was a suggestion to add "which the district will then validate". Also, #3, there was a question of, "how do we offer this".

5:280 - There was a question if "Bus Drivers" should go elsewhere.

5:320 - It was suggested to include an alignment to the Strategic Plan.

6:15 - #2, there was a question of "should we include 'as reported in the IL School Report Card" #4 or "the Illinois School Report Card"

6:50 - There was a decision to pull this from the first reading and do a side-by-side comparison with the PRESS example.

6:60 - There was a question on whether we should pull this from the first reading as it addresses safe gun storage.

6:130 - There were questions about the Program for the Gifted.

6:260 - There was a decision to pull this from the first reading, as there was confusion on what was the original policy vs. the suggested updates from PRESS, and suggested updates from administration.

7:70 - There was a suggestion to delete #8, and #15.

The Policy Committee decided to continue this meeting on January 10 at 4:30 p.m. in order to continue the Press 110 review and the Section 6 review.

<u>Motion:</u> R. Olejniczak moved and G. Scapillato seconded that the Board of Education adjourn the Policy Committee meeting.
