Greg Scapillato, Vice President of the Arlington Heights School District 25 Board of Education, called the special meeting to order at 6:03 p.m. on October 10, 2023. The meeting was held at the Dunton Administration Building, 1200 S. Dunton Avenue, Arlington Heights, IL. Roll call was noted and the Pledge of Allegiance said.

Secretary Pro Tem

Since Mr. Cerniglia was not present, Mr. Scapillato asked for a motion to appoint a Secretary Pro Tem for the meeting.

Superintendent Search Process

Mr. Scapillato introduced Dr. Tim Shimp and Dr. Bhavna Sharma-Lewis from School Exec Connect, who presented the Community Engagement report.

Dr. Shimp noted that School Exec Connect conducted focus groups and utilized an online survey to gather input from a variety of stakeholders. That information was used to create a New Superintendent Profile. There were 200 attendees at the focus groups, and the online survey received 722 responses. He reviewed the four guiding questions for the focus groups and survey.

Dr. Sharma-Lewis reviewed the participants in the focus groups. She also discussed the district's strengths which include student achievement; destination district; diversity; and resources. Dr. Shimp reviewed the district challenges, and the priorities for the first year.

Mr. Olejniczak entered the meeting at 6:22 p.m.

Dr. Shimp discussed the new Superintendent's desired skills and characteristics, the results from the community survey, and the qualities that the new Superintendent should possess. Next steps were outlined and include Dr. Sharma-Lewis and Dr. Shimp interviewing candidates, conducting reference checks, and recommending a slate of candidates to the Board; Board first and second round interviews; and the Board's selection of a finalist.

Mr. Scapillato thanked Dr. Sharma-Lewis and Dr. Shimp for all of their work. The presentation will be available in BoardDocs and on the Superintendent Search website.
